Ketchikan Theatre Ballet Tuition and Costume Assistance Program

Mission Statement: Our mission is to provide high quality dance instruction to foster each student's creativity and talents while developing a strong sense of confidence and self-discipline. Ketchikan Theatre Ballet (KTB) provides the community with cultural experiences in the form of student performances that involve participants and audiences of all ages.

The Financial Aid Program is funded by generous donations and grants and is subject to availability of funds.

The Purpose of the Fund is:

- To provide Financial Aid for dance instruction and costumes for KTB members, both continuing and new, who have demonstrated a strong desire to dance as well as have financial need or hardship.
- To expand into the community by providing an opportunity for students who could not otherwise participate in KTB because of financial need or hardship.
- To ensure that any student who demonstrates a desire to take classes and participate in performances by this program will not be impeded by financial concerns.
- To encourage further participation in the program and promote dance excellence.

Classification of Eligibility:

- Must demonstrate financial need by answering questions and providing paperwork as listed in application.
- Dancers must be a minimum of five years of age (no maximum age) currently in the dance program or seeking to enter the program.
- Dancers seeking Financial Aid must maintain 75% class attendance, be on time and prepared for class.
- Applications must be complete upon receipt, and delivered by the deadline in order to be considered for Financial Aid. Incomplete applications will automatically be disqualified from consideration for the current semester.
- Eligibility for any KTB financial aid, costume assistance and/or scholarships requires applicant and their immediate family members to be in good financial standing with KTB.

- Copy of current signed Federal Income Tax return as noted below

 - o Please submit only first two pages showing adjusted net income
- Alternative income documentation (if no IRS income tax documents), if applicable

Application Process:

Due Dates for Continuing Students (MUST BE RECEIVED BY THIS DATE- if mailing, please allow enough time)

- Full Dance Year: September 15th; Spring Classes (remainder of Dance Year): January 15th
- Costumes for Spring Gala: February 1st. Please note, in order to better serve more of our community, costume awards are for a partial amount of the costume cost. In the event that aid is awarded, a credit in the amount of the costume award will be applied to the applicant's Jackrabbit account. If the costume fee is more than your award, you will be responsible for paying the costume balance prior to picking up the costume.

New students and late enrollment:

 Applications for late enrollment and costume aid may be submitted at any time with instructor recommendation. Awards will be limited to the availability of financial aid funds.

Information will be held in strict confidence. Please return a **fully completed** application together with required documentation via email to board@ketchikantheatreballet.com, or deliver in a sealed envelope to the Office Manager during business hours.

Do not turn your application in to your instructor. Your instructor WILL NOT accept it. If you are emailing, please submit Microsoft office Word docs, .pdf, or .jpg scans, as all other formats will result in disqualification.

Applications may be obtained by visiting our website www.ketchikantheatreballet.com, asking your KTB instructor for forms, or by stopping by the Business Office during business hours. Please allow enough time to get your application in by the deadlines shown above.

Note: If emailing your application, you will be sent an acknowledgement receipt email to the email address you provided on the application. If you do not receive a confirmation within 3 business days, please email businessoffice@ketchikantheatreballet.com.

All applications will receive instructor recommendations. Please discuss financial aid options with your instructor and make them aware of your application.

Applications will be reviewed for approval and availability of funds by the Financial Aid Committee. Applicants will be notified via email as to the results between 5-10 business days after the applications are due for each term. If you do not have access to email, please provide a self-addressed stamped envelope so that a notice can be mailed to the address provided on the application. Application submission does not guarantee assistance.

Financial Aid funding is limited and will be awarded based on eligibility, timeliness, and funds available.

IMPORTANT NOTICES: Please note, in the event that aid is awarded, a credit in the amount of the award will be applied to the Jackrabbit account of the applicant. If the aid awarded is less than your tuition, you will be responsible for paying the tuition balance by the due date. Please reach out to the Business Office with questions about your account.

Financial aid will not be applied to prior year balances. All prior year balances must be paid, or the application will not be considered.

Parents of financial aid recipients will still be required to volunteer four (4) hours, during the dance year, and sell one (1) book of raffle tickets during each of our two annual raffle ticket sales, as stated in the KTB Handbook.
